At the same time, the fact that the students have the questions in advance has a wonderful palliative effect on students, putting them at ease because they know the questions in advance.

Additionally, the book is carefully edited with an eye towards the number of hours typically available for a class. The police practices material is designed to be taught in a three-hour class. The entire book is designed for a four-hour class.
